Objectives

- Promote The Society and its publications
- Provide membership support to student and Postgraduate members, encouraging engagement and membership progression
- Work with other Society Representatives within your region, including providing welcome, support and sharing best practice
- Promotes The Society's meetings and activities to your university
- Nominate potential successors and undergo a handover process as appropriate
- Where there is more than one Rep per university, coordinate activities through fellow Reps to ensure all Grant and Prize applications are agreed and submitted via one individual (where applicable).

Unlocking Futures Fund	Relaunches 31 January 2023	31 March 2023 15 September 2023	Up to £2500 for postdoctoral researchers who require an additional support to help them achieve their full potential. Funds cannot be used to pay for staff salaries but may be used for consumables, registration for Higher Education Academy Fellowship or other sundries that can be fully justified	Postdoctoral researchers at an institution in the UK or Republic of Ireland) with at least 1 year membership.
Institutional Engagement Award	1 September 2023	1 October 2023	Up to £500 to support Society Representatives and members to co-host events at their organisation, including internal conferences, teaching symposia, seminars or outreach events.	Society Rep or members of The Society (staff or students) with support of the Society Representative.
Research and Knowledge Exchange Award	20 February 2023	30 April 2023	£10,000 awards to support members wishing to conduct pilot studies, develop a new technique or to finalise a project.	Postdoctoral researchers, and those who are less than three years into their first permanent academic position (at an institution in the UK or Republic of Ireland). Postdoctoral researchers must have at least 12 months remaining on their contract from the grant start date. Applicants must hold a minimum of 2 years' consecutive membership.
Education & Teaching Award	20 February 2023	30 April 2023	£10,000 awards to support members to produce new educational resources, or to conduct a piece of publishable educational research that addresses a	Applicants must have 3 years of assured funding in a teaching-focused position (at an institution in the UK or Republic of Ireland)
